## CANAL CHARITY REFURBISHES NANTWICH WATERSIDE PLAYGROUND – OFFICIAL OPENING

A much-loved playground by the Shropshire Union Canal in Nantwich has been refurbished, thanks to the Canal & River Trust charity, WREN and Cheshire East Council.

The children's play area on Marsh Lane has benefited from a complete £58,000 renovation, including a new wide slide, swings, bench and safety flooring.

On Tuesday 17 April, all local children, friends and family are invited to the official community opening by Cheshire East Mayor and local councillor, Arthur Moran.

The Canal & River Trust, which cares for 2,000 miles of canals, owns the land and was granted funding from WREN's FCC Community Action Fund to improve the existing playground, which is now a welcoming, safe and accessible facility for the community and visitors to enjoy. Cllr Arthur Moran also supported the project with £1,000 from his Nantwich town ward budget.

•The Landfill Communities Fund - any waste that is discarded which cannot be reused, reprocessed or recycled may ultimately be disposed of in a landfill site. To encourage the re-use, recycle and recovery of more value from waste and use more environmentally friendly methods of waste disposal, Landfill Tax is charged on each tonne of waste sent to landfill. Landfill Operators (LOs) are able to redirect a small proportion of landfill tax liability (currently 6.8%) to support a wide range of community and environmental projects in the vicinity of their landfill sites through the Landfill Communities Fund (LCF). The LCF is regulated by ENTRUST on behalf of HM Revenue & Customs, and the projects are delivered by enrolled Environmental bodies (EBs). Since its inception in 1996, over £1 billion has been spent on more than 32,000 projects across the UK.
